- **Larch Tree (*Larix laricina*)** is a source of Arabinogalactans, which support the immune system in its production of immune cells and supporting healthy cell replications.<sup>†</sup>

- **Zinc** is essential for a healthy immune system.<sup>†</sup> It is required for the development and activation of T-Lymphocytes, a kind of white blood cell that helps fight infection.<sup>†</sup>
